# Electronic NUMbering tElephone NUmbers Mapping

ENUM is an IETF standard (RFC3761) finalized in April 2004 that allows an end user to type a telephone number into e.g. a Web browser and to access a listing of Internet resources (URI) for that number, such as addresses for IP telephony, e-mail or Web sites.




# **WG ENUM Goals**




### ∺User ENUM vs. Infrastructure ENUM Subscriber (End User) opt-in vs. Provider (Operator) opt-in

### ℅Public ENUM vs. Private ENUM Internet vs. managed IP-Networks (or intranets)


## **ENUM** root
